RULES and REGULATIONS

- 1. This is a one day event, Sunday September 18, 2016, 11am-7pm at the Hanford Mall.**
- 2. \$250 per 10x10 exhibitor booth space, additional table space may be purchased if available must provide your own table and table covers. Or \$175 for a table top area, table and table cover are provided.**
- 3. Canopies and pop-up booths are not permitted for this event in the Mall.**
- 4. Electricity is limited but available on request for an additional \$25 exhibitor must provide the extension cords. Extension cords must have rubber mat covers or be taped to the floor.**
- 5. Exhibitors can start setting up for the event at 8am, Sunday September 18th.**
- 6. Exhibitors load and unload at service access #2 only (close to the food court), as marked on the layout we provided. No entry thru Mall doors will be permitted.**
- 7. Exhibitors must be ready for business by 11am with no breakdown before 7pm and must be vacated at 9pm.**
- 8. Exhibitors products must be wedding related with no adult products. Mall Management has the right to remove items that are not approved.**
- 9. Mass manufactured products must have prior Mall Management approval.**
- 10. Exhibitors must be available and supervise their table space at all times.**
- 11. Amplified music, alcohol, food, beverages, e-cigarettes, and pets are not prohibited (only personal assistant dogs are permitted).**
- 12. Smoking is prohibited inside and outside the mall.**
